### **SECTION 4: First aid measures**

### 4.1 Description of first aid measures

General: In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth

to an unconscious person.

If breathing is irregular, drowsiness, loss of consciousness or cramps: Call 112 and give immediate

Eye contact: Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15

### 5.2 Special hazards arising from the substance or mixture

Hazards from the substance or

Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. ### 5.3 Advice for firefighters

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. ### 6.1 Personal precautions, protective equipment and emergency procedures

# 6.2 Environmental precautions

### **SECTION 7: Handling and storage**

### 7.1 Precautions for safe handling

Vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapors in air and avoid vapor concentrations higher than the occupational exposure limits. In addition, the product should be used only in areas from which all naked lights and other sources of ignition have been excluded. ### 11.1 Information on hazard classes as defined in Regulation (EC) No 1272/2008

Exposure to component solvent vapor concentrations may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system. Solvents may cause some of the above effects by absorption through the skin.
